Sasaram, Distt. Rohtas entrusting the subject matter of the Trust in the Board of Trustees, constituted earlier and confirmed by this deed (hereinafter called the Board) as set forth herein below.

(11) GENERAL

the trustees will not be entitled to receive any remuneration, but the trustees may reimburse themselves all expenses actually incurred by them in connection with the trust or their duties relating thereto.

(12) The accounting year of the trust shall be the financial year ending on 31st March every year.

(13) It is expressly declared that this is a public charitable trust. No part of the trust fund, either corpus or income therefrom shall be utilised for any purpose other than that of the trust hereby created or for any purpose which is not a charitable purpose in law.
